A RESOLUTION OF THE TOWN OF WHITEHALL AMENDING THE TOWN'S RESOLUTIONS NO. 4.96 AND NO. 8.95 BY AMENDING SECTIONS 3.02, 3.03 AND 3.10 AND THEREBY AUTHORIZING A REDUCED INTEREST RATE AND PROVIDING FOR OTHER MATTERS RELATING THERETO.

WHEREAS, the Town of Whitehall (the "Town") has undertaken to acquire and construct improvements to its water system and obtained grants in the amounts of \$500,000 from the State of Montana under the Treasure State Endowment Program and a Community Development Block Grant (CDBG) in the amount of \$325,000 for a portion of the cost of such undertaking; and

WHEREAS, the Town made application to Rural Development (RD) for a loan in the amount of \$450,000 to finance the remaining portion of the cost of acquisition and construction of the Town's water system, and RD has indicated its willingness to loan the Town said funds upon certain conditions and requirements; and

WHEREAS, the Town, by Resolution No. 4.96 authorized the issuance of the Town's water revenue bond in the amount of \$450,000 to pay a portion of the cost of acquiring and constructing its water system; and

WHEREAS, after receiving bids for the acquisition and construction of the water system project, it was determined by the Town that the costs of completing the construction and acquisition of the Town's water system were greater than the amount of funds the Town would have available through grants and loans for such improvement project; and

WHEREAS, the Town has made application to the RD for an additional loan in the amount of \$59,000 and the RD has indicated its willingness to grant and to loan to the Town such additional sums to complete the construction of the improvements to the Town water system; and

WHEREAS, the Town by its Resolution No. 8.95, dated November 10, 1997, amended Town Resolution No. 4.96 to provide for the issuance of an additional bond in the amount of \$59,000 which, together with the \$450,000 bond, are collectively referred to herein as the "Series 1998 Bonds"; and

WHEREAS, the water development project to be funded by the Series 1998 Bonds is substantially complete and accepted by the Town; and

WHEREAS, the Town received notice on August 21, 1998, from RD that the Series 1998 Bonds are eligible for a lower interest rate of four and three-fourths percent (4.75%) as opposed to the earlier quoted rate of 5.125%, and the Town would like to receive the new rate; and

WHEREAS, additional amendments to Town Resolutions No. 4.96 and No. 8.95 are required to effectuate such changes and to accommodate RD requirements.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF WHITEHALL, JEFFERSON COUNTY, STATE OF MONTANA, AS FOLLOWS:

- 1. Amendment of Section 3.02. The interest rate on both the Scries 1998A and 1998B Bonds shall be 4.75% per annum and the Series 1998A and 1998B Bonds shall each have a term of 20 years and be fully amortized over such term.
- 2. <u>Amendment of Section 3.03</u>. Section 3.03 of Resolutions No. 4.96 and 8.95 shall be amended to read as follows:

Section 3.03 Payment Schedule. The principal of and interest on the Series 1998 Bonds shall be payable in monthly installments with the first installment due one month from the date of the issuance of the Series 1998 Bonds and the remaining payments due on the same day each month during the term of the Series 1998 Bonds until the principal of and interest on the Series 1998 Bonds has been paid in full. Principal and interest payments will be in the amount of \$2,912 per month for the Series 1998A Bond and \$382 per month for the Series 1998B Bond and shall be paid on the monthly installment dates (the 17th of each month, beginning October 17, 1998) for the 20 year term of the Series 1998 Bonds. The final monthly installment may be in such lesser or greater amount as is necessary to pay the balance of principal and interest then remaining due.

3. Amendment of Section 3.10. Section 3.10 of Resolution No. 4.96 shall be amended to read as follows:

Section 3.10 <u>Priorities and Additional Bonds</u>. The Series 1998 Bonds shall be issued on a parity basis with the Series 1992 Bonds. While the Series 1992 Bonds are outstanding any additional bonds,

other than the Series 1998 Bonds, may be issued, provided the provisions of Section 7 of Town Resolution No. 8.92 are first followed. After the Series 1992 Bonds are paid in full, additional bonds may be issued on a parity with the Series 1998 Bonds upon the same provisions described in Section 7 of Resolution No. 8.92, provided, however, that the Net Revenues to debt service test shall be reduced from 125% to 120% and that no additional bonds will be issued to "advance refund" (within the meaning of Section 149(d) of the Code) any Series 1998 Bonds.

4. Remainder of Resolution No. 4.96, as amended by Resolution No. 8.95, in Full Force and Effect. Except as amended herein, Resolution No. 4.96, as amended by Resolution No. 8.95, shall remain in full force and effect.
